**SECTION 6****ACCIDENTAL RELEASE MEASURES**

<b>Personal Precautions, Protective Equipment and Emergency Procedures:</b>	Remove sources of ignitions, do not turn lights, or unprotected electrical equipment, on or off. In case of a major spill, or spillage in a confined space, evacuate the area and check that solvent vapor levels are below the Lower Explosive Limit (LEL) before re-entering.
<b>Environmental Precautions:</b>	Do not allow spills to enter drains or water courses.
<b>Methods and Material For Containment and Cleaning Up:</b>	Ventilate the area and avoid breathing vapors. Take the personal protective measures listed in Section 8. Contain and absorb spillage with non-combustible materials (e.g. sand/earth/vermiculite).
