Precautionary Statement

First Aid

If in Eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

If on Skin or Clothing: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15 to 20 minutes. Call a poison control center or doctor for treatment advice.

General Information

Bio-Film Extra is a self-emulsifiable, nonionic spreader sticker adjuvant intended for use with most plant protection products in which the label permits the use of a spreader sticker. Bio-Film Extra is compatible in spray solutions with most commercial plant protection products and foliar feed micronutrients. A thin coating of Bio-Film Extra spreader sticker forms an elastic film and bonds the accompanying tank mix product to the plant foliage. This enhances the efficiency of the spray application and minimizes loss through rainfall or irrigation run-off.

Directions For Use

Ground Application per 100 Gallons of Spray Mix:

Fungicides and Acaricides.....	2 to 8 fl. oz.
Insecticides.....	2 to 8 fl. oz.

Air Application:

Depending on usage and spray equipment.....8 fl. oz. per acre

Observe spray patterns and adjust the amount of Bio-Film Extra as needed.

Mixing Instructions

Fill the tank 1/2 full of water and start agitation. Add plant protection and/or micronutrient products as indicated by their label, or follow this order:

1. Water (as specified by pesticide labels)
2. Add all pesticides or spray materials
3. Begin agitation
4. Add Bio-Film Extra

Storage and Disposal

Do not contaminate water, food, or feed by storage or disposal.

Storage: Store above 32° F. Store away from heat or open flame and oxidizing materials.

Disposal: Wastes resulting from this product may be disposed of on site or at an approved waste disposal facility. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
