## First Aid

## General Information

Hi-Surf COC is a nonionic blend of surfactants and highly refined phytobland paraffin oil. It is designed for use with a broad range of pesticides where an oil concentrate adjuvant is recommended.

Hi-Surf COC increases contact activity and penetration of the spray while also providing uniform coverage on leaf surfaces. Always follow herbicide label recommendations.

## Directions For Use

Read directions and conditions of sale and warranty before purchasing or using this product. Use strictly in accordance with accompanying pesticide label warnings and directions. Hi-Surf COC may be applied by ground, CDA or aerial application equipment along with any other spray equipment recommended by the pesticide label.

**For Ground Applications:** Hi-Surf COC can be substituted for traditional crop oil spray adjuvants at significantly lower use rates. Hi-Surf COC is generally recommended at a rate of 2 quarts per 100 gallons (0.5% v/v) of spray solution. For spray volumes below 12.5 gallons per acre, use Hi-Surf COC at 1 pint to the acre. Always follow recommendations of the pesticide label if higher rates are required.

**Aerial, Low Volume, CDA:** Use Hi-Surf COC at 2 to 8 fluid ounces per acre or follow rate recommendations on the pesticide label if higher rates are required. Generally Hi-Surf COC will provide equivalent results at one-half the use rate of traditional crop oil concentrate adjuvants.

**DO NOT ADD THIS PRODUCT AT A RATE THAT EXCEEDS 2.5% v/v OF SPRAY VOLUME.**

## Mixing Instructions

To prepare for pesticide application, fill spray tank 2/3 full with water and begin agitation. Add pesticide or fertilizer as recommended and then add Hi-Surf COC while continuing agitation. Continue to agitate until tank is full and agitate before and during each application.
