### Hazard Statements

## First Aid

## General Information

Vapex, a VaporGrip Xtra Agent may be used as an additional tool to reduce volatility potential when tank mixed with dicamba.

Use of Vapex, a VaporGrip Xtra Agent does not replace an approved drift reduction adjuvant (DRA). This product does NOT control drift.

Vapex, a VaporGrip Xtra Agent is a volatility reducing agent but does NOT fully eliminate all volatility potential.

## Directions For Use

Always follow the precautions, restrictions, recommended use rates, and application directions appearing on the labels for each product to be tank mixed.

**Use Rate:** Use Vapex, a VaporGrip Xtra Agent at a rate of 20 fluid ounces per acre. Always follow dicamba product label requirements.

While the carrier is agitating, add Vapex, a VaporGrip Xtra Agent to the spray tank first during the mixing and filling process.
