**SECTION 4****FIRST AID MEASURES**

<b>Eyes:</b>	Immediately flush eyes with plenty of water. Get medical attention, if irritation persists.
<b>Skin:</b>	Remove contaminated clothing. Rinse skin immediately with water for 15-20 minutes. Call a poison control center or doctor for treatment advice. Immediately call a poison control center or doctor. Dilute with large amounts of water. Do not induce vomiting unless directed to do so by a medical professional.

**SECTION 5****FIRE FIGHTING MEASURES**

<b>General Hazard:</b>	Toxic fumes may be emitted in a fire situation.
<b>Extinguishing Media:</b>	Foam, dry chemical, carbon dioxide, water spray or fog.
