Although the contents are completely organic, avoid prolonged or repeated skin contact and inhalation. Wash hands with mild soap after use. Use of a dust mask, safety glasses and protective gloves when applying peat based inoculants is recommended.

### Directions For Use

**Slurry Method:** The optimum method for applying Exceed Peat Garden Combo is the slurry method. In a container outside of the planter box, dampen the seed with non-chlorinated, clean, cool water at a rate of 8.5 ounces of water per 50 pounds of seed. Add appropriate amount of inoculant (2.5 ounces per 50 pounds of seed) and mix water, seed, and inoculant thoroughly until seed is uniformly coated. Allow 1 to 3 minutes for mixture to dry and then plant as soon as possible.

**Applied Directly to Seed:** Exceed Peat Garden Combo can also be applied dry directly onto the seed. Mix seed and inoculant thoroughly until seed is uniformly coated. Layering seed and inoculant will aide in this process. NOTE: Maximum seed adhesion will not be obtained by applying this product dry.

**For Seed Pre-Treated With Fungicide:** Applying the inoculant dry is recommended for seed that is pre-treated with fungicide. NOTE: Maximum seed adhesion will not be obtained by applying this product dry.

**For New Legume Soils:** For soils that have never been host to the legume being planted, apply Exceed Peat Garden Combo at a 1.5 to 2.0X rate, or use Exceed Peat Garden Combo with a liquid inoculant product.

### Storage, Disposal and Handling

**Storage:** Inoculants require more care than the average chemical or seed treatment product because they contain live bacteria susceptible to environmental conditions during storage. Viable bacterial numbers will survive if stored properly until the expiration date.

Store in a cool, dry place out of direct sunlight. Store between 40°F and 77°F. Do not allow the inoculant to freeze and thaw repeatedly. Do not store outdoors or unprotected from elements. Do not leave in warehouse if fumigants are in use.

**Disposal:** Destroy unused product after labeled expiration date. Outdated inoculant should be discarded into the normal trash stream. Expired product contains only peat humus.

**Handling:** Do not open until ready to use. Use before expiration date. Exceed Peat Garden Combo carries a one-season shelf life.
