SECTION 4: FIRST AID MEASURES

DESCRIPTION OF FIRST AID MEASURES

4.1. General:	In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing Media:	Recommended extinguishing media: alcohol resistant foam, CO ₂ , powder, water spray. Do not use water jet.
5.2. Special Hazards Arising From the Substance/Mixture:	Irritating or toxic substances may be emitted upon thermal decomposition. Thermal decomposition products may include oxides of carbon as well as smoke and fume.
5.3. Advice For Firefighters:	Evacuate area. Prevent contamination from run-off of adjacent areas, streams, drinking water and sewers. Do not flush down sewers or other drainage systems. SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Precautions/Procedures:	Keep all sources of ignition away from spill/release. In case of a major spill or spillage in a confined space evacuate the area and check vapor levels.
6.2. Environmental Precautions:	Do not allow spills to enter drains or water courses.
6.3. Methods and Material For Containment and Cleaning Up:	Ventilate the area and avoid breathing vapors. Take the personal protective measures listed in Section 8. Contain and absorb spillage with non-combustible materials (e.g. sand/earth/vermiculite).
