SECTION 4: FIRST AID MEASURES

DESCRIPTION OF FIRST AID MEASURES

4.1. General:	In all cases of doubt, or when symptoms persist, seek medical attention. Never give anything by mouth to an unconscious person.

SECTION 5: FIREFIGHTING MEASURES

5.1. Extinguishing Media:	Alcohol resistant foam, CO ₂ , powder, or water spray. Do not use water jet.
5.2. Special Hazards Arising From the Substance/Mixture:	Combustion may yield smoke, carbon monoxide, and other products of incomplete combustion. Oxides of sulfur, nitrogen or phosphorus may also be formed. Never use welding or cutting torches on or near container, even if empty.

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal Precautions, Protective Equipment, Emergency Procedures:	Keep all sources of ignition away from spill/release. In case of a major spill or spillage in a confined space evacuate the area and check vapor levels.
6.2. Environmental Precautions:	Do not allow spills to enter drains or water courses.
6.3. Methods and Material For Containment and Cleaning Up:	Ventilate the area and avoid breathing vapors. Take the personal protective measures listed in Section 8. Contain and absorb spillage with non-combustible materials (e.g. sand/earth/vermiculite). Place in closed containers outside buildings and dispose of according to the Waste Regulations (see Section 13). Clean, preferably with a detergent. Do not use solvents.
