General Information

Mainstay Elite is an advanced adjuvant formula containing a blend of surfactant components typically found in 90/10 nonionic surfactants combined with ethoxylated vegetable oil to deliver the efficacy of an oil concentrate while maintaining the crop safety of a nonionic surfactant.

Mainstay Elite is intended for use with pesticides that are labeled for agricultural and horticultural spray applications.

Mainstay Elite provides wetting and uniform coverage of the spray and reduces the tendency for wash-off of spray deposits by rainfall, dew or irrigation. The antifoam agent in Mainstay Elite minimizes troublesome foam.

Mainstay Elite can be used with a range of pesticide applications including glyphosate or combination sprays that recommend nonionic surfactants and/or oil adjuvants.

Directions For Use

Mainstay Elite is intended for use with pesticides that are labeled for agricultural and non-agricultural uses. Mainstay Elite cannot be used for aquatic applications. Some pesticide labels recommend a higher or lower surfactant use rate for optimum efficacy. Follow the pesticide label directions when this occurs.

Use Rate: Use 1 to 4 pints per 100 gallons of spray mix.

For use with glyphosate herbicides refer to the herbicide label for recommended surfactant rates. Do not add this product at a rate which exceeds 1.0% of the finished spray volume. For wettable powders, water soluble materials and emulsifiable products add Mainstay Elite in water after a good mixture is formed.

Mainstay Elite can be used with most insecticides, fungicides, herbicides, defoliants and desiccants to improve the performance of the active spray ingredients by giving more uniform distribution and better wetting of the plant surface.

Mainstay Elite is a broad-spectrum adjuvant specifically designed for optimum activity enhancement when used with a wide range of pesticides and solvents such as water, aromatics, alcohol and alphatics.

Prior to using Mainstay Elite, read and follow all instructions that appear on the pesticide label that are to be tank mixed with this product.

For wettable powders or emulsifiable liquids, add Mainstay Elite after a good mixture has been formed.
