### Directions For Use

**Post emergence herbicides:** 1 to 4 pints per 100 gallons (0.125% to 0.500% v/v) spray solution.

**Fungicides, insecticides, acaricides:** 4 to 8 fluid ounces per 100 gallons.

Unless instructed otherwise by accompanying pesticide label, add 90% Nonionic Surfactant as the first component to the spray tank.

### Storage, Disposal & Spill

Do not contaminate water, food or feed by storage or disposal of this product.

**Storage:** Store in a well-ventilated place. Keep cool. Store in a tightly closed container. Store in original container only.

**Disposal:** Triple pressure rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
