General Information

Hydro-Wet Injectable improves the infiltration and penetration of applied irrigation water onto highly maintained turf areas.

Hydro-Wet Injectable can be used on all types of irrigation injection systems.

Hydro-Wet Injectable is formulated to treat soil repellency and enhance soil moisture content.

Hydro-Wet Injectable can also be applied using conventional ground spray equipment.

Directions For Use—For General Turf Use

Injection Application: Inject Hydro-Wet Injectable at a rate of 12 to 24 fluid ounces per acre monthly, or as needed throughout the growing season.

For More Difficult Areas: Hydro-Wet Injectable may be injected up to 48 fluid ounces per acre.

Conventional Sprayers: Apply 3/4 to 1 fluid ounces, diluted in 1 gallon of water spray, per 1,000 square feet of turf area. Apply monthly throughout the growing season.

Spray Applications

Add 12 to 24 fluid ounces of Hydro-Wet Injectable per 100 gallons. Hydro-Wet Injectable should be compatible with most tank mix companion products. Read and follow the label instructions of the accompanying products to ensure that Hydro-Wet Injectable is appropriate for such use. If no recommendations are available for such use, conduct a jar test with all ingredients to confirm compatibility and spray apply mixture to small treatment area to confirm plant safety prior to large scale applications.

First Aid
