### **GENERAL INFORMATION**

STEELY RED is a pigment based liquid seed colorant in combination with iron designed to clearly identify treated seed and deliver supplemental iron nutrition to germinating seeds and emerging plants during stand establishment.

#### DIRECTIONS FOR USE:

SHAKE WELL OR OTHERWISE AGITATE PRODUCT PRIOR TO USE.

Always check compatibility of all treatment components prior to large scale mixing.

Add STEELY RED to treatment slurry water first and prior to treatment pesticides. Mix treatment slurry thoroughly prior to seed application.

Use Rates\*:

Soybeans, Wheat, Rice, Corn, Sorghum..... 0.50 to 1.00 fluid oz per 100 lbs of seed Cotton.... 1.00 to 3.00 fluid oz per 100 lbs of seed

\*Suggested rates. Some color variation may occur. Adjust rates to obtain the desired color and coverage due to seed size, seed coat, application equipment, and total applied slurry rate application.
