Directions For Use

Golf Course Greens and Tees: For use as a season-long preventive treatment, apply Tournament-Ready Granular at a rate of 2.0 to 2.5 pounds per 1,000 square feet in early spring. To maintain initial spring treatment, apply Tournament-Ready Granular at a rate of 1.25 pounds every 2 to 4 weeks as needed. Irrigate treated areas lightly following application to move Tournament-Ready Granular from the granule carrier and into the root zone. Tournament-Ready Granular should be applied to dry turf.

Golf Course Fairways, Athletic Fields and General Turf Areas: Apply at a rate of 88 to 109 pounds per acre. Reapply at monthly intervals or as required. Due to a wide variety of spreaders available, it is recommended that the operator calibrate his spreader to achieve the desired rate of 1.0 to 2.5 pounds per 1,000 square feet. Results may very based on equipment, operator, and environmental variables beyond the manufacturer's control.

Soil Mixes and Lawn Care: Apply Tournament-Ready Granular at a rate of 2.5 pounds per 1,000 square feet.

Newly Planted Nursery Materials: Thoroughly mix 2.5 pounds of Tournament-Ready Granular per cubic yard of backfill.

Soil Media: Blend up to 2.5 pounds of Tournament-Ready Granular to each cubic yard of soil mix.
