### Storage, Disposal & Spill

Do not contaminate water, food or feed by storage or disposal of this product.

#### General Information

Spray-Tek is a water conditioning agent and nonionic surfactant formulated to enhance pesticide performance. Spray-Tek improves the spreading and activation of pesticides. Hard water cations and high pH can decrease mixability and solubility of certain pesticides, especially glyphosates, 2,4-D amines, and garlon salts. Ammonium sulfate has long been recognized to aid in the effective uptake of certain pesticides by some plant species. Spray-Tek contains ammonium sulfate as well as acidifying, buffering, and chelating agents which aid in maintaining the right pH in the tank mix solution, and blocks hard water cations from interacting with the pesticide molecule.

#### First Aid

**If in Eyes:** Rinse continuously with water for several minutes. Remove contact lenses if present and easy to do; continue rinsing. If eye irritation persists, get medical attention.

If Swallowed: Rinse mouth. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Do not give anything by mouth to an unconscious person. If you feel unwell, call a poison control center or physician immediately for treatment advice.

**If Inhaled:** Move person to fresh air and keep at rest in a position comfortable for breathing. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. If you feel unwell, call a poison control center or physician for further treatment advice.

If on Skin or Clothing: Rinse skin immediately with plenty of soap and water for 15 to 20 minutes. If skin irritation occurs, get medical attention. Take off contaminated clothing and wash before reuse.

Refer to pesticide label for specific crop use and application rates. Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over Directions For Use referred to on this label.

**General Use Rates:** 1 to 4 quarts per 100 gallons of spray water

For Smaller Weeds: 1 to 2 quarts per 100

gallons of spray water

For Larger Weeds: 3 to 4 quarts per 100

gallons of spray water

**For best mixing results:** Fill spray tank 1/2 full with spray water and begin agitation; next add Spray-Tek; while maintaining agitation, add desired amount of pesticides.
